Minutes of Second Meeting of Uttarakhand Medical Council

Second meeting of the Uttarakhand Medical Council was held on proposed date on 2nd March 2014, beginning at 2:00 P.M. at Meeting Hall of Regional Family Planning Centre at 107, Chander Nagar, Dehradun. The following members were present:-

- 1. The minutes of the last council meeting held on 5th January was confirmed. Dr.Bist, Registrar, informed the members that in an information to querry under provisions of RTI Act 2005, he has given the minutes of last meeting along with the Uttarakhand Medical Council Act and Rules, as desired by the questioner.
- 2. President desired that minutes of the meeting should be recorded in English.
- Dr. Vipin Mehra suggested that proceedings of the meeting should be Recorded by audio visual device and / or entire proceedings with every word should be recorded and/or only conclusion of discussion to be recorded.
- **3.** President intervened and suggested that minutes of 2nd March 2014 be recorded in writing by Dr Bist and Dr. Mehra.

- **4.** Dr. Vipin Mehra suggested that after five years term of first registration when the term ends all registered Doctors of Uttarakhand be informed through letters. For (Renewal) of registration.

- Dr. G.S. Joshi (D.G. Med. Health) suggested that all registered practitioners be informed two months in advance of their due renewal date, so as they can get them renewed in time.
- Dr. R.K. Singhal was of the opinion that all renewals be completed by June every year. However the decision of fixing date for registration could not be agreed upon as the five years of registration date of each doctor is different and it terminates in each case separately after 5 x 365 days.
- Dr. K.C. Pant suggested that for speedy completion of the process of renewal of doctors all institutions like IMA, D.G. Medical Health, Principals of Medical Colleges be sensitized through letters.
- **5.** President insisted that website for the council be created at an early date and processing of online registration and renewal should be started at an early date after enswering that physical verification of the Doctor should be ensweed.
- **6.** After deliberations and considerations it was agreed that a fees of (**Rs. 2000/-**) Rupees two thousand be fixed for issuance of Good Standing Certificate and (**Rs 500/-**) Rupees five hundred be fixed for issuance of N.O.C. The necessary charges have to be brought by in procedure rules for implementation.
- 7. In discussion for draft proposals in respect of seminars and workshops in CME where in all members actively discussed and deliberated on various issues and aspects required to be looked into and scrutinized for retaining transparency of allotment of **CREDIT HOURS** and

also about the fee to be charged as Council may have to pay with some allowances to be appointed as auditors of CME. However, it was decided at last by the President that Dr. Jethani and Dr. Mehra shall prepare a comprehensive plan and place it before next council meeting. The regulation so drafted shall have to be added to the Rules for making it part of the Act.
