## Minutes of Executive Meeting held on 21/09/2014

State Executive Meeting of Uttarakhand Medical Council, was held on 21/09/2014, following members were present.

The meeting was presided by Dr. Bhim Singh Pandhi, (President) Uttarakhand Medical Council.

Dr. Y.S. Bist (Registrar) informed the members of the meeting that the council has written a letter to Medical Council of India, about the action to be taken against the doctors who have not registered in Uttarakhand Medical Council. The Medical Council of India has been asked for the directions in this regard. Copy of which was also sent to I.M.A., Dehradun. Dr. Bist informed that no notice was given to I.M.A.

Further Dr. Y.S. Bist informed that some of the applicants for registration are such who are already registered with Karnataka Medical Council, but their address are of Uttarakhand. Whether such applicants should have taken N.O.C. from the related state before registration.

The opinion of the executive was requested in this regard.

Dr. R.K. Singhal (Member) informed that any doctor practicing in any state is required to get himself registered with that state and is required to pay the registration fee prescribed by the state.

Dr. S.L. Jethani informed that if we practice in Delhi, we have to get our-self registered with Delhi and then only we can practice in Delhi. If someone is a government servant in that case he has to get himself registered in the state where he is serving.

Dr. Harish Kohli informed that dr Kuldeep Dutta I.M.A., Dehradun (President) has announced in a C.M.E. of I.M.A. that the Medical Council Uttarakhand has agreed for registration of the I.M.A. member.

Dr. Bist informed that in Punjab Medical Council, there is a procedure that doctor has to deposit his original registration certificate and then only N.O.C. is being issued, by Punjab Medical Council.

Dr. S.L. Jethani advised that the procedure of the registration should be, where the doctor is registered – with some other he should be registered with Uttarakhand Medical Council add on registration with the original registration. And those who wants to register their additional degree with the council, in such cases the council will write a letter to the College/ University whether the qualification is recognized or not and then only the registration will be done, as a new case.

All the members opined that all the doctors practicing in Uttarakhand State will be required to get themselves registered with Uttarakhand Medical Council, and then only they will be entitled for medical practice.

Dr. S.L. Jethani said that the medical practitioners of Uttarakhand may be informed by way of information in newspapers that any doctor serving in the State or doing practice, is required to get one registered in Uttarakhand Medical Council. Further it was decided that the Director General Medical Health & FW, Uttarakhand should be requested by writing a letter from the council that all the serving medical officer's should get themselves registered with the Uttarakhand Medical Council with immediate effect, The D.G. Should also be requested to supply the list of all the medical officers working with the districts, so that others who are not registered may be asked for registration.

Dr. Singhal advised that a letter should be written to C.M.O. Haridwar, that Dr. Pradeep Kumar is still doing the practice in spite of the fact that M.C.I. has suspended his registration for 2 years.

The next meeting of Uttarakhand Medical Council will be held on 26/10/2014.
